## 2012 Championship

### **Highlights**

The dynasty continues: Concordia-St. Paul (33-4) claimed its record-tying sixth consecutive Division II Women's Volleyball Championship December 8, defeating Tampa (32-4) in an epic five-set thriller (27-29, 17-25, 25-23, 25-23, 16-14) at West Florida.

The Golden Bears tied the NCAA all-divisions women's volleyball record for consecutive championships, joining Division III Washington-St. Louis (1991-96).

After dropping the first two sets of the match, head coach Brady Starkey said he told the team between the second and third sets, "We've got'em right where we want'em. This is you guys all the way. Nothing will feel better than coming back from down 0-2 and to win in five.

"And in the huddle, I never looked at them and saw that they were defeated; they were all like 'We're good!' and they were."

The win improves Concordia-St. Paul's NCAA tournament win streak to 36 consecutive matches and its all-time NCAA tournament record to 44-4 in 10 appearances. The Golden Bears are now 6-1 in seven trips to the national championship match, all under the direction of Starkey.

Concordia-St. Paul has defeated Tampa twice in the championship match in the last three years, also doing so in 2010 in four sets. It's the third straight year that the Golden Bears have eliminated Tampa in the tournament, winning in three sets last year in the semifinals.

Concordia's six total titles are the most in Division II. Tampa earned its fourth runner-up finish to go along with its 2006 championship.

Senior Ellie Duffy led the Golden Bears with 23 kills. Junior Kayla Koenecke also reached double figures, posting 20 kills and 15 digs for her 13th double-double of the season. Sophomore Ashley Murtha led the defense with 18 digs.

Junior Amanda Konetchy produced 72 assists - the fifth-highest total in a single match in school history.

Concordia's four All-Americans - Cassie Haag, Konetchy, Duffy and Koenecke - were named to the all-tournament team.

Duffy said, "You come in and work hard and do what him (Starkey) and (assistant coach) George (Padjen) tell you and good things are going to happen. I think he shies away from the credit, but they have a lot to do with how successful this program has been.
